
Types of Admissions

- Regular – Deadline
- Rolling Admissions
- Early Admissions
- Open Admissions
- Contingent
- Auto-acceptance
- Deferred



Historical approach to admissions

- More emphasis on quantitative information
 - GPA
 - Standardized Test Scores
 - Law or Regulation Based
- Less emphasis on qualitative
 - Success and Achievements
 - Academic Rigor

 - Holistic Admission

Impact of Data Analytics

- Identify non-compliance
- Identify internal control gaps
- Identify fraud, waste and abuse
- Evaluate admissions results



Identifying Internal Controls

Access Control

- Principle of Least Privilege
- Approach to Access – role based versus direct grants
- Annual Access Reviews
- Restrict Access to critical processes and data
- What changes in the “new world”?
 - Not much...but be mindful of
 - Unauthorized access
 - Remote access through personal devices
 - Unpatched systems

Information Transfer

- Encrypted
 - Stored Securely
 - Secure Transmission
 - Dedicated Secure Portal
 - Secure Video Platforms
- What changes in the “new world”?
 - Not much...but be mindful of
 - Data security
 - Data flows
 - Privacy



Technical Process

- Receipt of test scores
 - Receipt of transcripts
 - Account creation
- What changes in the “new world”?
 - More high schools provide transcripts electronically
 - Stronger identify verification practices


Documentation

Document the Process

- Enrollment strategies
- Information Collection, Transfer, and Security
- Criteria, Application Review, Decision Making, Approval

Document Basis for Admit/Deny

- Quantitative Only
- Personal attributes and experience
- Other (scholarship \$\$ not available)



Fraud Risk

- Inconsistent practices
 - Erroneous/Inflated admissions counts
 - Lost revenue from unapproved tuition waivers
- What changes in the “new world”?
 - Increased documentation of decisions
 - Enhanced verification procedures
 - Increased oversight of the application of tuition waivers

Increasing Your Use of Analytics

- Compliance with admission standards
 - Auto-acceptance
 - Minimum GPA requirements
 - Test Score requirements
- Compliance with admission processes
 - File review
 - Appeal
- Fictional students/False Identities
- Probability of an admit/deny decision v actual results (Logistic regression)



Understanding your population

- Incentives
- Unique Programs
- Financial Aid Packaging
 - Scholarships
 - Title IV Programs
- Data Fields
 - Type of admission
 - Test scores
 - GPA
 - Dates (submission, admittance)
 - Demographic and biographic indicators

Using Data Analytics

- Non-compliance with Admission Standards
 - Test scores
 - GPA
 - Late admissions
 - Assured admissions (top 10%-25%)
- Non-compliance with Admission Processes
 - File reviews
- Fictitious students
- Incorrect ethnicity indicators



Using Logistic Regression

- Post Audit tool
- Simple and efficient
 - Relationship between measurable characteristics and outcome
 - Characteristic (e.g. GPA, Test Score, Residence, Class Ranking)
 - Outcome
 - Admit/Deny: 0/1
 - Predicts the probability of an admit/deny decision

Example of Logistic Regression

- Population
 - 1462 applicants
- Accuracy
 - Acceptance 78%
 - Denials 90%
 - Overall 86%

Prediction	Actual	
	Accepted	Denied
Acceptance	395	96
Denial	110	861

Understanding your results

- Expected / Unexpected Results
- Correlation to Other Information
 - Revenue
 - Actual enrollment/SCH
- What is the story that the data is tell?
 - Human error
 - Broken process
 - Undocumented decisions






